We still have money for storm damage. In 2022 we were spared. We had very minor damage. It was a good year.

Carol is hoping that during the remainder of this year we can focus on ground cover. There are areas that are looking overgrown and ragged. We use Executive Lawn Care and will ask them to take care of clearing invasives and cleaning up around stones. Carol will walk through the cemetery with Rick.

Austin raised an issue about natural burial. If we are going to take this on as an option will there be expenses to set it up? There would be some expense to

create a separate area within the cemetery with a plaque or sign. There may be roots that need to be removed in a proposed new area.

We have talked about adding one or two benches to the cemetery. Rick priced some stone ones out and will do more research on other traditional shapes besides a kidney shape. Carol and Kristin will also ask the New England Cemetery Association about what they suggest as appropriate for our landscape style.

Austin asks that we look at the budgets in one integrated document. It would be very helpful if we can see a spreadsheet that would show actuals and budgets and projections by each year so we can follow trends. Austin will happily put it together. Rick will send reports to Austin to compile with information about this year, last year and the future.

With regard to installing pavers by the gate and the entrance into the oval, Rick addressed Austin's recommendation for historical bricks, and he has presented two samples. It was agreed upon that we should research other materials and start with an actual design plan with square footage, either created by Rick and Carol or a professional landscape designer. Rick's estimate is 3,600-3,700 square feet with a 10% overage. Rick will come up with a design and we will go from there. Kate would like a breakdown of material options.

A motion was made to accept the grounds budget by Austin and second was made by Tom. All were in favor.

A 2023 donations proposal was presented by Carol. This proposal has already been accepted by the Donations Committee: Kate, Tom, Dexter and Carol. The committee has met and decided that it makes sense to stick with our current roster of organizations, which represent our interest in supporting arts and education. Carol requested proposals from the organizations.

### **Donations Proposal 2023**

The following grants have been approved by the committee, which includes a one-time \$1,000 gift to the Manchester Historical Society for the Sculpture Project, which will go toward a likeness of Emily Cheney Neville to be installed at the Mary Cheney Library for upgraded lighting. Carol will ask Betty Ann Grady at the Hartford Foundation to process the gifts.

Kristin made a motion to approve the budget for 2023 donations. Rick seconded and all were in favor.

With new Mary Cheney Library proposed, what will they do with the existing library location? One idea is the Lutz Children's Museum which is on the outskirts of town with parking being an issue. Carol will find out what the plan is from Doug McDonough, the Director of the Library.

Austin revisited the idea of transferring funds from our investment account, which supports CCA operations, to the Foundation account, which supports our philanthropy, brought up at last year's meeting because we have a substantial endowment, more than we need to maintain the cemetery. This report summarizes his research to see if we should move any money. The bottom line is that we are spending about the range that a conservative nonprofit spends, 4%. His conclusion is we should not transfer funds,but keep all of our money in this investment pot because the interest it is supporting most of the maintenance of the cemetery.

A motion was made to approve by Carol and Rick seconded. All were in favor.

### Succession

Carol has been President since 2002, and it is time to work out a succession plan. Carol said that the Foundation does have the capacity to administer the donor-advised fund, but the cemetery would need someone to look after it. There are other considerations, such as family genealogy and helping members place historical objects and documents in permanent. The New England Historical Society has a program for looking after cemeteries, but Carol does think we need to have a succession plan and she would like input on how we should handle this. Carol expects to retire from the president position in the next two years. Kristin would also move on to working for a non-profit she has founded this past year. Austin thinks that the controls have been superior and really need to be a family matter. If we start turning over big aspects of this to outside organizations it will fall into oblivion. Perhaps the Town of Manchester can run the cemetery. Austin worries about the family association being lost over time. Membership has been declining over time as generations of the family have moved away from Manchester and have not shown an interest in CCA. Ideally, we will identify a younger Cheney who is an attorney or accountant that could take this on. We want to maintain the lineage and if we outsource, we may lose it. We have two years to find a Cheney that can step up.

Tom would like to continue with a position on the board with whomever the next generation of leadership is. We don't want to dissolve the Association that is over one hundred years old so if we can find a cousin that would be fantastic. Rick mentioned his son who is local and is a senior financial analyst however he just had a new baby, so he is very busy. It could be a team of two people. Kate likes the team idea because we have two purposes, one is to continue to give money and that won't go away. This will continue with the Foundation. Then there is the financial oversight of running the cemetery. Two people could do this. She doesn't feel that it must be super time consuming. We have time to put this out and paying someone would sweeten the pot. We will look at the membership. Kristin will send the list of members to the board. Perhaps we look at Rick's son for the financial side. Perhaps there is another member that could do the donation/Foundation work. There is another family history aspect to this and communications that Carol and Kristin do – writing, updating the website and responding to family members so we do need to consider these things. Austin asked if we actually own the cemetery land? Carol thinks it is owned by the Association, but we will check documents and speak with our Lawyer Malcolm Barlow. Austin sees the cemetery side being done professionally but this depends on how much control we have. Perhaps we hire someone to manage the cemetery with Board approval and direction.

Carol and Kristin will also investigate other Associations and cemeteries. Let's plan a directors meeting in September. Carol, Kristin, and Rick will write up job descriptions and an estimation of time to help with the search.

In discussing the relevance and longevity of the CCA, the directors were in favor of putting on a family reunion in Manchester in the coming two years. This would require volunteer involvement.

The meeting was adjourned at 10:55.
